### Storing and parking vehicles and recreation equipment

In NDIP, many residents store vehicles or recreation equipment on the grounds of their home. Over the years, various practices have been tolerated that are not in accordance with regulations concerning storage and parking. However, after many comments and complaints, <u>as of this spring</u>, the City will be obliged to strictly apply the bylaw regarding the storage and parking of vehicles and recreation equipment and to correct the practices of non-compliant owners.

At present, storage of recreation equipment is permitted under certain conditions. Regulations govern the length of time permitted, depending on the location of the storage or parking area (e.g. in the front yard, at the side or in the back), and the minimum distance from property lines and roadways.

Non-compliant storage or parking areas will no longer be tolerated, even if clean and tidy. The City cannot permit exceptions to regulations based on aesthetic and subjective criteria.

The City is therefore asking all owners of vehicles or recreation equipment to take note of the applicable regulations by visiting the Urbanisme, permis et inspection section (urban planning, permits and inspections) of the NDIP website or by calling Land Management (514-453-4128, option 1) to ensure that their storage or parking area complies with regulations.

### » AGROFORESTRY PROJECT

In September 2012, Council members voted to support the implementation of an innovative agroforestry project managed by CLD Vaudreuil-Soulanges on land along Don-Quichotte Boulevard. The goals of the project are to set up, with the participation of several partners, a large-scale experimental site to test and demonstrate intercropping techniques. This agroforestry approach consists of planting rows of widely spaced trees and cultivating crops such as grain in the space between the trees. The project will analyze the interaction between crop production and slow- or fast-growing or nitrogen fixing trees in order to develop sustainable farming techniques with direct benefits for local communities and next-generation farms.

Work to prepare the site will begin in spring 2013 (removal of brushwood, ploughing, harrowing, levelling and ditch digging) and a portion of the site will be given over to rapid cultivation (vegetable crops). The first trees will be planted in 2014. Since two thirds of its territory is agricultural, NDIP is proud to participate in this agroforestry initiative, probably one of the largest in Quebec, which will investigate issues relating to the presence of trees in an agricultural environment and encourage research aimed at reconciling agricultural productivity with environmental quality.

The Council members and all municipal employees would like to congratulate Mélissa Arbour-Lasalle, who is in charge of urban planning at the Land Management department, who recently scored an outstanding success in the qualifying exam for the Ordre des urbanistes du Québec. As a an urban planning specialist whose expertise and skills are now formally accredited by the Order, Ms. Arbour-Lasalle is responsible for quality of life and harmonizes activities and planning in our territory to meet the needs of NDIP residents. Congratulations!

### Did you know...

During winter, six municipal employees, including two fulltime workers, are assigned to maintaining NDIP's five outdoor rinks. In addition to clearing the snow and watering the rinks, their duties also include general maintenance of the heated cabins and chalets available for skaters and hockey players. The rinks are generally maintained and watered between 4:00 AM and 12:00 noon, seven days a week. Our teams take advantage of each cold spell to keep the ice in good condition as long as possible.

In 2013, the rinks' performance record is very positive. For the first time in years, a rink was open to the public before Christmas, by December 23 in fact. Although thaws and rain have made things somewhat difficult, our teams had the expertise to manage the situation, thanks to all the preparatory work and watering carried out early in the season.

# **GREEN THUMB**

### Changez d'air! Program

What could be nicer in winter than keeping warm with a good old log fire! Unfortunately, heating with wood can be a major cause of air pollution. Conventional stoves are responsible for 40% of all particulate matter emissions in Quebec.

Mindful of this situation, members of Council at the session of November 2012 adopted a resolution to participate in the Changez d'air! Program. This program, promoted by the Association québécoise de la lutte contre la pollution atmosphérique (AQLPA) in partnership with members of the Association des professionnels du chauffage (APC) and the Ministère du Développement durable, de l'Environnement, de la Faune et des Parcs (MDDEFP), provides incentives for owners to stop using old-style wood-burning stoves or to replace them with 70% less polluting equipment.

Specifically, owners will receive a subsidy totalling \$200 for removing a stove or \$600 for replacing an old stove with an approved model, including a \$100 contribution from the City.

The City strongly encourages owners of old wood-burning stoves to take advantage of this opportunity to improve the air we all breathe.
